

What's Your Status?

Why Does It Matter?

Team Members are either:

Full Time: 60 hours or more per pay period Part Time: Less than 60 hours per pay period PRN: No budgeted hours, as need/as available

Team member status determines which benefits they are eligible for and paid time off accruals.

When can you make changes to your benefit elections?

Changes to benefit elections can be made upon hire, during annual enrollment (effective 1/1/23) and within 30 days of a qualifying event:

- -Loss of existing coverage
- -Eligibility of new coverage
- -Marriage, Divorce, Birth, Death

Why are status and qualifying events important?

Group health insurance is guaranteed coverage for anyone in our organization and has tax advantages - the insurance company has to accept you. To minimize their risk there are rules governing the plan such as status and qualifying events. This prevents members from picking up insurance, receiving covered services and dropping it, etc. It also helps keeps costs controlled for the entire group which keeps premiums lower for all members.

Why would you want a Group Health Plan vs. an Individual Health Plan?

Group health insurance is guaranteed – the insurance company cannot deny your coverage because of health conditions or previous claims and your rates are guaranteed and the same for everyone on the plan. Your premiums are also deducted pre-tax.

Winning Wheels, Inc. worked hard to bring the organization a group health plan. In order to provide coverage and make it affordable, Winning Wheels, Inc. pays the majority of the monthly costs for the team members.
